### Background

#### Overconcentration in Ulaanbaatar City

 Despite rapid economic growth, population and industry are concentrated in the capital (about 46% of the total population and about 62% of businesses)

#### Serious Urban Problems


• Urban problems such as lack of infrastructure (public transportation, sewage treatment, etc.) and environmental pollution are becoming more serious as the population is concentrated in the capital

#### Disparity between Urban and Rural Area

 Lack of social services in rural areas, disparities in rich and poor, and decline in employment opportunities

- Capacity development of the C/P to formulate and revise the NCDP.


## Intermediate Outcome


### <u>First Draft of NCDP - Examining the future of the whole country</u> <u>from a cross-sectoral and long-term perspective</u>




Analysis of Land Use Plan for NCDP

## Initiatives to build consensus among stakeholders

- Stakeholder meetings were held in all prefectures (21 Aimags) to gather local opinions for regional development
- Scenario planning (Continuous multistakeholder meetings with government agencies, academic researchers, private companies and others)




## Scenario planning = $\frac{Process to build consensus}{among stakeholders on their shared future}$

- 1) Selection of members for multi-stakeholders (MSH) meetings
- 2) MSH meeting based on following discussion points (Examples):
  - Macro development objectives and basic strategy,
  - Development frameworks, and
  - Development alternatives
- 3) Determination of subjects and schedule of subsequent MSH meetings

## Capacity development and stakeholder network building

- Introduce Japan's experiences and lessons through training in Japan and issue-specific training, and develop skills in spatial and national development planning.
- Building stakeholder network from the past JICA projects (Over 20 years cooperation for urban development of Ulaanbaatar city)
